

QUOTATION – TERMS & CONDITIONS

Supplied quotation is to be considered in conjunction and in accordance with the following:

- Quotation does not include cost of removal/disposal of any surplus sands/materials from site, unless otherwise stated above.
- •All site/preparation works are to be completed by builder/client.
- •Upon completion of preparation works, site is to be inspected and accepted by SDii Group prior to commencement of works.
- •No allowance has been made for concrete pump hire, unless otherwise quoted.
- •Additional charges may apply to placement of product to rear of property, if any.
- •Colour selection to be confirmed in writing or as part of acceptance stage, prior to scheduling and acceptance of works by SDii Group.
- •All natural poured limestone is based on "Holcim Natural Limestone". SDii Group Pty Ltd does reserve the right to source alternate supplier without notice, if or when considered necessary to ensure satisfaction of proposed works.
- Quotation is based on estimated quantities (as per plan provided by you) and final quantities will be subject to final site measurement upon completion.
- •In the event that site has not been inspected. Quantities are to be confirmed at site stage, prior to scheduling of works.
- Percentage deposit will be required at acceptance stage and/or prior to scheduling of works, unless credit account terms are in place.
- •No allowance is made for traffic management. Any traffic management requirement consideration is to be dealt with at site stage and provided for by builder/client, if or when required.
- •Any proposed works are to be in accordance with Cash Sale Agreement, unless otherwise agreed in writing by SDii Group Pty Ltd prior to acceptance of any proposed works.
- •All council specification and approval consideration to be dealt with by builder/client and confirmation/instruction to be provided to SDii Group Pty Ltd prior to scheduling of works, if any.
- •Shrinkage and/or hairline type cracking is an inherent part of the concrete curing process and on occasion may occur. SDii Group is unable to guarantee against this type of cracking and no responsibility is taken towards removal and/or replacement.
- Variation in colour, exposure, texture and/or finish may occur from time to time within all natural concrete type products, and SDii Group Pty Ltd will not be responsible for inconsistencies within mix designs and/or selected colours.
- •Minimum quantity charges will apply Based on 50 square metres.
- •Unless otherwise stated, all exposed and honed aggregate products will be installed inclusive of steel mesh and expansion foam as per site requirement and circumstance. (This is with exception of Natural Poured Limestone and Oxided Concretes which are to be individually quoted, if or when required.)
- •Acid washing, cleaning and solvent based sealing is included for all exposed and honed aggregate products. (Excluding natural limestone products.)
